**County Proposition**  
**Millage for the Continuation of the**  
**Marquette County Transit Authority (MARQ-TRAN)**

**To provide local funds for the continuing operations and capital purchases of the Marquette County Transit Authority (MARQ-TRAN) on all properties within the County of Marquette, Michigan, shall the total amount of ad valorem taxes collected be renewed at and increased up to the previously authorized six-tenths (.6) of a mill (\$0.60 per \$1,000.00 of Taxable Valuation of real and taxable personal property), of which .5911 mill is a renewal of the previously authorized millage and .0089 mill is a new additional millage, for a period of seven (7) years, 2020 through 2026? The taxes collected the first year would amount to approximately \$1,461,643.**
